Why Are We Here?

- Salary Commission has a long history in Snohomish County.
 - Started out as an Advisory Committee to the County Council
 - Has been in place since 1997
- In 2006, voters approved an amendment to the Snohomish County Charter creating an independent commission.
- The Commission sets the salaries for the County Council, Executive, Assessor, Auditor, Clerk, Sheriff, Treasurer and Prosecuting Attorney for the next two years, starting January 1.
 - Salary schedule is due no later than July 1.

SNOHOMISH COUNTY SALARY COMMISSION**

The Citizens' Commission on Salaries of Elected Officials was created to "study the relationship of salaries to the duties of all Elected officials and shall fix the salary for each position." It is comprised of ten members; six of them are selected by lot by the County Auditor, one from each Council district and one at-large member who may reside anywhere within the county. The remaining four appointments are nominated by the County Executive; of these four members, one is selected from each of the following sectors in the County: business, professional personnel management, legal profession, and organized labor. The County Council may confirm or reject nominations made under this subsection. Board members serve two-year terms and are limited to two consecutive terms. Contact: Marcia Isenberg, ext. 3660.

How Members Are Appointed

- Commission is comprised of 10 members.
 - Six selected by lot by County Auditor: one per Council district plus one “at large”
 - Four selected by Executive with experience in personnel representing business, professional personnel management, legal profession, and organized labor
 - Confirmed by County Council
- Term
 - Two years
 - Two terms maximum
- Compensation
 - None; eligible for mileage reimbursement to and from meetings



Things You Should Know

- Meetings are subject to the Open Public Meetings Act and public disclosure.
- Four meetings are scheduled.
 - May 25: Kick-off
 - June 1: Salary discussion
 - June 8: Public hearing
Continuation of salary discussion and possible adoption of salary schedule
 - June 15: Wrap-up (if needed)



Commission's Responsibilities

Include:

- Studying the relationship of salaries to duties of the elected officials
- Establishing the salary schedule for each elected official for next two years
- Serving as an independent body with the fullest cooperation of all elected officials, departments and agencies of the County

Do not include:

- Evaluating performance of elected officials
- Recommending policy changes
- Weighing in on political issues
- Making budget recommendations



Other Things To Consider When Setting Salaries

The salary schedule:

- Allows the County to attract a diverse group of quality candidates
- Can be implemented with available County resources
- Contains clear rationale
- Reflects the market in some way
- Has the confidence of Commission members

Note: While salaries fixed by the Commission are not subject to approval by the County Council or County Executive, a petition may be placed on the ballot to challenge the Commission's decisions.

Elected Official Salary Schedule January 1, 2015 – December 31, 2016

The Snohomish County Citizens' Commission on Salaries of Elected Officials, pursuant to SCC 2.105 and Charter section 6.120, hereby adopts the following salary schedule for elected officials for 2015 and 2016:

1. The annual salaries paid to the following elected officials for the fiscal year beginning January 1, 2015, shall be those base amounts stated below increased by ninety percent (90%) of the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) for the Seattle-Tacoma-Bremerton area for the period of June 2013 to June 2014. Base salary amounts are equal to the average of similar positions in other jurisdictions that were surveyed.

2. The annual salaries paid to the elected officials identified in Section 1 for the fiscal year beginning January 1, 2016, shall be the annual salary paid to the official for fiscal year 2015 increased by ninety percent (90%) of the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) for the Seattle-Tacoma-Bremerton area for the period of June 2014 to June 2015.
3. In addition to the amounts established in Sections 1 and 2 above for a County Council Member, the annual salary of the Chair of the County Council shall include an additional amount equal to ten percent (10%) of the regular Council Member salary for that year.
4. The salary paid the Prosecuting Attorney shall be equal to the salary paid Superior Court judges as determined by the Washington Citizens' Commission on Salaries for Elected Officials under Article XXVIII of the Washington Constitution and Chapter 43.03 RCW.

Methodology Used to Determine Salaries for Executive, Assessor, Auditor, Clerk, Sheriff and Treasurer

Different approaches have been used to determine base salaries of Snohomish County elected officials.

1. Executive, Assessor, Auditor, Clerk, Sheriff and Treasurer

- Over the last 10+ years, elected officials received the same cost-of-living (COLA) increases as non-represented employees and negotiated settlements with AFSCME, the County's largest bargaining unit. The only exceptions were 2009 and 2012 due to negotiated settlements with AFSCME.
- During the economic downturn, salaries for elected officials were frozen for three years (2010-2012) and salaries for non-represented and AFSCME employees were frozen for two years (2010 and 2011).

2. County Council

- For the last six years, salary determinations for the County Council have paralleled those of other elected officials. Earlier, there were different approaches used.
- During the economic downturn, salaries for County Council members were also frozen for three years.

3. Prosecuting Attorney

- In 2002, the County Council approved a recommendation of the 2001 Salary Commission to tie the salary and any COLA paid to the Prosecuting Attorney to the salary paid to Superior Court Judges as determined by the State's Salary Commission. This approach is in effect today.
- The Prosecuting Attorney's salary was frozen for six years because of the link to the state judiciary.
