2 **a. Growth Monitoring Report - Draft**

3 Steve Toy walked the PAC members through data showing changes in population
4 growth in the county. He said he would send the presentation slides to the members
5 along with tables for each individual city. The members had no objection to briefing the
6 Steering Committee at their July 22, 2020, meeting.

10 **b. Infrastructure Financing and Conservation Opportunities in Snohomish Co.**

11 Nicholas Bratton briefed the PAC members on Transfer of Development Rights (TDR)
12 tools and an incentive found in RCW 39.108. Members asked about the number of
13 "sending" sites in Snohomish County, how to use TDRs to complement their efforts to
14 provide affordable housing, and how to make TDRs more attractive to developers when
15 the receiving zone is already allowing for substantial density.

20 Steve Toy reported that the SCT Steering Committee approved the BLR Methodology
21 report at their June 24th meeting. The County Council will be briefed in January, 2021.
22 He is working on how to gather data from each city for the BLR without being able to
23 meet face-to-face.

26 Laura Benjamin reported on PSRC board activities and announced that the committees
