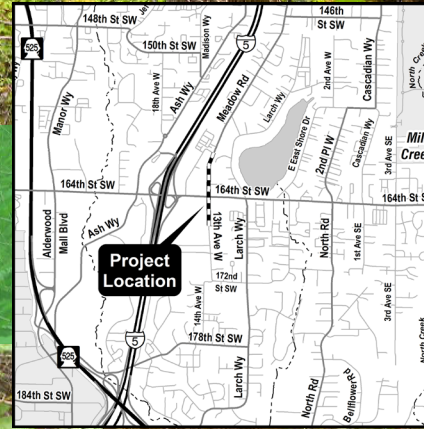


Notice of Land Disturbing Activity (LDA) Permit Application Interurban Trail Improvements - 160th St. SW to 167th Pl SW



Project Type: Trail Improvements

Description:

Snohomish County Public Works proposes to construct Interurban Trail improvements along the west side of 13th Ave West / Meadow Rd and would extend from 160th St SW to 167th Pl SW. The improvements will provide a continuous shared use path that is separated from the roadway by curb and gutter. The area of disturbance would total 0.63 acres, with a Cut quantity of 140 CY and a total Fill quantity of 440 CY. The project is scheduled to be constructed in 2025 depending on funding availability and permit approvals.

Location:

The proposed improvements would be located on 13th Ave West / Meadow Rd and extend from 160th St SW to 167th Pl SW.
