Road & Trail Improvements Coming to the Lynnwood Area

Alderwood Mall Parkway Corridor

Proposed improvements include widening Alderwood Mall Parkway to five lanes from the 16800 block to the SR 525 northbound ramps. The project would add a center turn lane, raised bike lanes, sidewalks, gutters, curbs, drainage facilities, three fish passage culverts, and new traffic signals at the SR 525 northbound ramps intersection. Snohomish County is also scheduled to overlay Alderwood Mall Parkway from 164th St SW to the Lynnwood city limits at the same time as the widening project. Construction is tentatively scheduled for 2024.

Ash Way Corridor

Snohomish County is proposing improvements for the Ash Way corridor between Admiralty Way/Gibson Rd and the roundabout at 18th Ave W. Improvements include widening the road to three lanes, adding pedestrian and bike facilities, improving intersections, and adding stormwater treatment facilities. The project is expected to be constructed in phases.

Interurban Trail Improvements

Snohomish County is proposing to construct a missing link of the Interurban Trail between 160th St SW and 167th Pl SW. The project will provide a continuous pedestrian and bike facility on the west side of Meadow Rd/13th Ave W. Construction is tentatively planned for 2025, subject to funding availability.

36th/35th Ave W Improvements

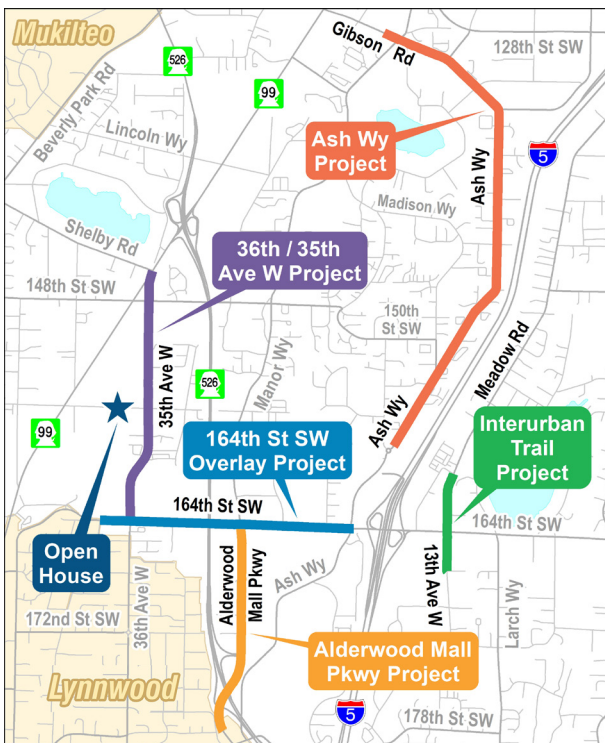
The planned improvements to the 36th/35th Ave W corridor, between 164th St SW and SR 99, include adding a center turn lane, sidewalks, bike lanes, bus pullouts, streetlights, landscape features, and stormwater drainage facilities. The project has full funding with construction scheduled to begin in 2023. These improvements mirror the work completed in 2020 by the City of Lynnwood on 36th Ave W in the city limits from 165th Pl SW to Maple Rd/179th St SW.

164th St SW Overlay

Snohomish County is scheduled to overlay 164th St SW from Spruce Way to Ash Way during summer 2023. The work will improve the driving surface for motorists and extend the life of the road by grinding away the existing top layer, performing pavement repair, and then overlaying the asphalt. It will also upgrade pedestrian facilities with ADA-compliant curb ramps and install conduit for future Accessible Pedestrian Signals (APS) installation. Single-lane closures and night construction are possible. Access to businesses and sidewalks will be maintained.
