Thank you for your interest in the Snohomish County Sheriff's Office Volunteer Program. Keeping Snohomish County safe is a shared responsibility and we need your help. I hope you'll join the hundreds of other community-spirited citizens who have chosen to give the valuable gift of their time to support public safety.

As a volunteer, you become a member of the Sheriff's Office team. You'll find that screening for our volunteer program is more thorough than most organizations. That's because our volunteers have access to Sheriff's Office information and will sometimes hear and see material that is confidential.

**Application Process**

Here are the five steps in our volunteer application process, which usually takes a few weeks to complete:

1. **Initial interview and fingerprinting.** This is done at the Sheriff's Office administrative offices at the County Courthouse Everett (3000 Rockefeller Ave).
2. **Completion of a personal history packet.** This packet is so we can get to know you and serves as the basis for your polygraph examination.
3. **Background investigation.** This may include a criminal records check, a check of references listed in your packet, and any other sources necessary to ensure all volunteers meet the standards of the Sheriff's Office.
4. **Drug screening.** This is a simple urinalysis, done at a health clinic in Everett, at the Sheriff's Office expense.
5. **Polygraph examination.** Because of the nature of information that volunteers come into contact with at the Sheriff's Office, we must maintain the highest ethical standards for all employees, including volunteers. This is not a "gotcha" test. You'll meet privately with the polygraph detective to review your personal history packet and will have an opportunity to fully discuss your answers. Only the final few minutes of your session with the polygraph detective are spent hooked up to the polygraph machine. You will know in advance what questions you'll be asked; the polygraph merely assures that all answers are truthful. This also is done at the Sheriff's Office administrative offices in Everett.
