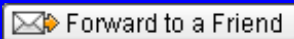

Happy Spring!

Thank you for subscribing to my monthly newsletter.

**Courthouse Update:** As you may have read, Snohomish County reached an agreement with the City of Everett in which the County has agreed to pay \$5.5M for a parking facility at an undisclosed location. I am opposed to the project in its current form and strongly opposed the idea of adding the unnecessary parking garage. Although, I have voiced legitimate concerns for the past year, the County has decided to push ahead. I will continue to monitor the courthouse project closely and will bring issues to light as they will inevitably arise. We must be vigilant on the long term health of the county's finances. This week I have found out that the county ended 2014 with reserves of 7.4%. This is far below the County's stated policy of 11%. With the County's finances still in a degraded position the County should avoid any further added costs for the project. While I am disappointed, I promise to continue to monitor the project and provide you with updates as I receive them.

**Stilly Valley Youth Project (SYVP):** After the release of the State House Capital Budget, I was disappointed to find that the House left the SYVP out of their budget. Fortunately, \$2.242M has been included in the Senate's capital budget. This of course leaves a gap from the original request, but I am confident that we can work with our partners to ensure all

critical components of the project receive the necessary level of funding.
