County Budget deliberations begin:

The County Council received the proposed 2015 budget from the Executive's office on September 30. The Council members, their aides and analysts will review the proposed budget throughout October and November. The County Council will work with the Executive to develop the best possible budget for the county.

There will be at least two public hearings on the budget. One will be in the Council Chambers located on the 8th floor at 3000 Rockefeller at 6:30 p.m. on Monday, October 13. The second will be held in McCollum Park on Monday, October 20.

Anyone can speak to the council on the budget or any other topic at the beginning of the Monday Council meeting for General Administration at 10:30 or General Legislative Session on Wednesdays at 9 a.m.

I need to hear all points of view before I vote on the final budget in late November. The budget is posted on line at <http://snohomishcountywa.gov/367/Budget-Division>.

Emergency ordinances regarding marijuana

The County Council passed two emergency ordinances regarding the potential siting of marijuana production and processing facilities in the R-5 zone and the number of "collective gardens" in the Clearview Rural Commercial (CRC) zone. The purpose of the emergency ordinances is to provide a "time out" while the Planning Commission and Council have the opportunity to thoughtfully consider possible new regulations or standards. The emergency ordinances can be in effect for six months.

A Public Hearing is required for each emergency ordinance. Those Public Hearings are scheduled for Wednesday, October 29. If you are interested, more information is available at the County Council web site, www.snohomishcountywa.gov/2288/Meetings-Webcasts.

Tree Ordinance Update

The council is considering a new tree ordinance. The ordinance proposes a new approach based on long-term tree canopy coverage.

At the October 1 Public Hearing on the proposed ordinance, numerous amendments were offered and the council received extensive public testimony. To allow time for consideration of all the new information, the public hearing was extended to Wednesday, October 8.

Enterovirus D68 confirmed in Snohomish County - *courtesy of the Snohomish County Board of Health*

The Centers for Disease Control and Prevention (CDC) has confirmed the presence of enterovirus D68 (EV - D68) in Washington state, including Snohomish and King Counties.

The CDC testing confirmed that two children, one from Snohomish County and one from King County who had been hospitalized at Seattle Children's Hospital has respiratory illness associated with EV-D68.

"The spread of EV-D68 reminds us how important it is to get back to basics: washing hands, covering coughs, & staying home when ill," said Dr. Gary Goldbaum, MD, MPH, Director and Health Officer of the Snohomish Health District. "And although here is no vaccine for this virus, with flu season approaching, we also need to get vaccinated in order to protect all of us."

The Port of Everett has gone out to bid for a \$2.6 million wharf strengthening project to support heavy lift operations at the South Terminal.

The project, made possible through a grant from the taxpayers of Washington State, will strengthen 140 feet of the 700 foot dock in the South Terminal. This project will allow the Port to better handle its rolling cargoes, and most importantly, use its mobile harbour crane at the South Terminal. This project will double the wharf working load capacity.

The project will be complete in March 2015.
