

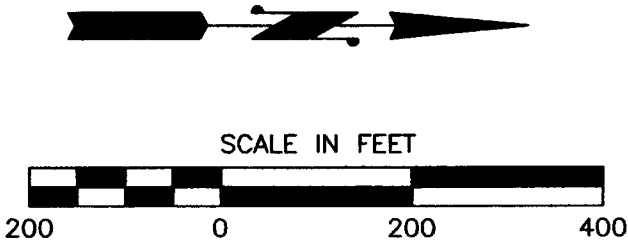
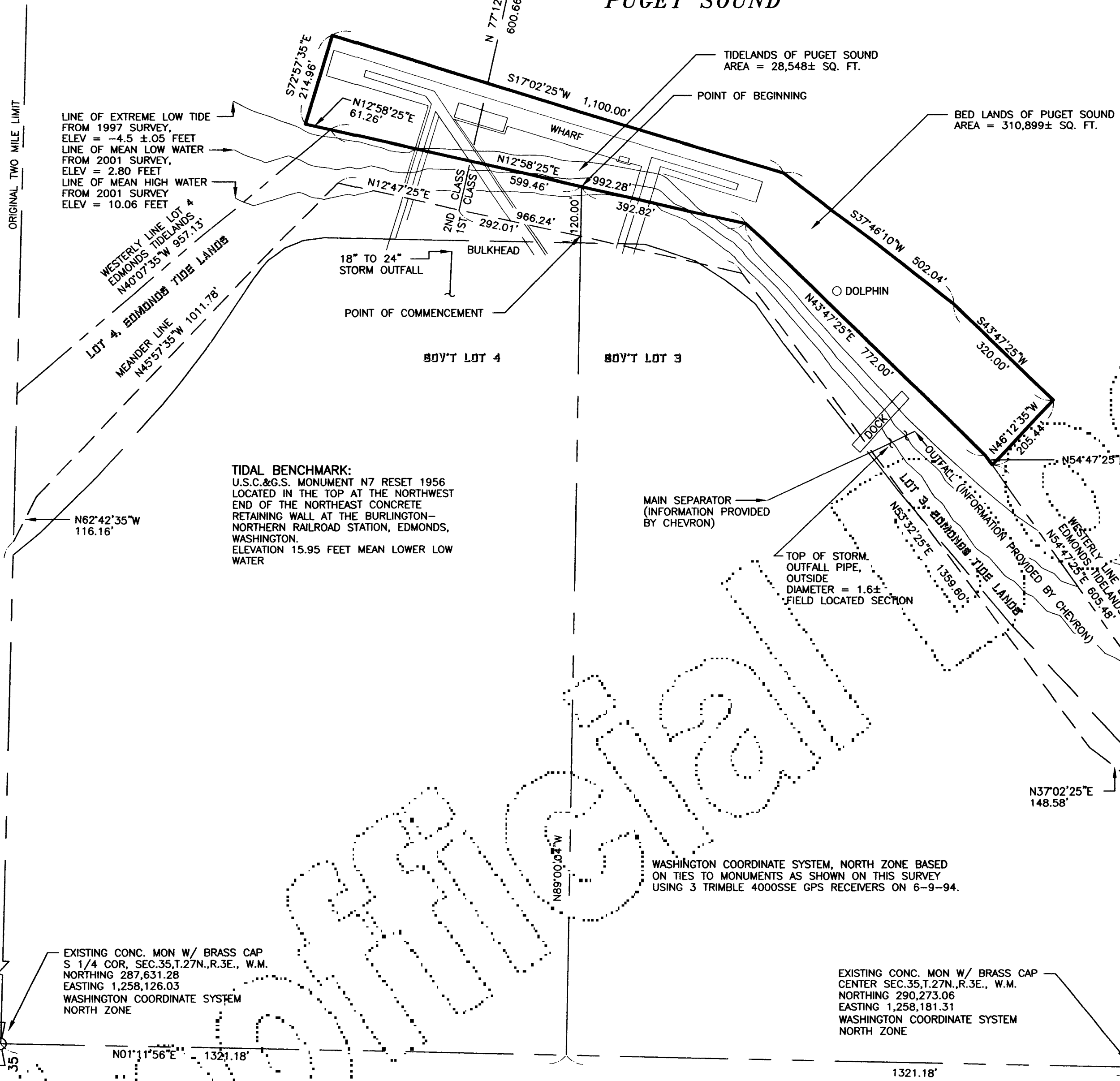

PUGET SOUND

LEGAL DESCRIPTION

THAT PORTION OF THE TIDELANDS AND BED LANDS OF PUGET SOUND, OWNED BY THE STATE OF WASHINGTON, INCLUDED WITHIN THE LIMITS OF A TRACT DESCRIBED AS FOLLOWS:  
COMMENCING AT THE SOUTHWESTERLY CORNER OF GOVERNMENT LOT 3, SECTION 35, TOWNSHIP 27 NORTH, RANGE 3 EAST, W.M.;  
THENCE NORTH 89°00'04" WEST ALONG THE SOUTH LINE OF SAID GOVERNMENT LOT 3 A DISTANCE OF 120.00 FEET TO THE SOUTHWEST CORNER OF LOT 3, EDMONDS TIDELANDS, AND THE POINT OF BEGINNING;  
THENCE NORTH 12°58'25" EAST ALONG THE WESTERLY LINE OF SAID LOT 3 A DISTANCE OF 392.82 FEET TO AN ANGLE POINT IN SAID WESTERLY LINE;  
THENCE NORTH 43°47'25" EAST ALONG SAID WESTERLY LINE OF SAID LOT 3 A DISTANCE OF 772.00 FEET TO AN ANGLE POINT IN SAID WESTERLY LINE;  
THENCE NORTH 54°47'25" EAST ALONG SAID WESTERLY LINE OF SAID LOT 3 A DISTANCE OF 28.52 FEET;  
THENCE NORTH 46°12'35" WEST 205.44 FEET;  
THENCE SOUTH 43°47'25" WEST 320.00 FEET;  
THENCE SOUTH 37°46'10" WEST 502.04 FEET;  
THENCE SOUTH 17°02'25" WEST 1100.00 FEET;  
THENCE SOUTH 72°57'35" EAST 214.96 FEET TO THE INTERSECTION OF THE WESTERLY LINE OF LOT 4, EDMONDS TIDELANDS, SECTION 35, TOWNSHIP 27 NORTH, RANGE 3 EAST, W.M. PRODUCED SOUTHWESTERLY;  
THENCE NORTH 12°58'25" EAST ALONG SAID SOUTHWESTERLY EXTENSION OF THE WESTERLY LINE OF SAID LOT 4 A DISTANCE OF 61.26 FEET TO THE SOUTHWESTERLY CORNER OF SAID LOT 4;  
THENCE CONTINUING NORTH 12°58'25" EAST ALONG SAID WESTERLY LINE OF SAID LOT 4 A DISTANCE OF 599.46 FEET TO THE POINT OF BEGINNING;  
CONTAINING 339,447 SQUARE FEET, MORE OR LESS.
