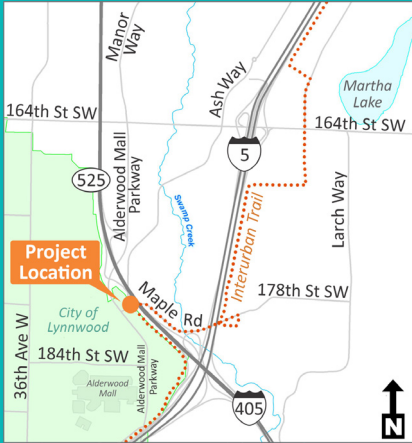


# Maple Rd and Ash Way

## Intersection Improvement Project

Snohomish County and the city of Lynnwood are partnering on a project to help ease flooding at the Ash Way and Maple Rd intersection by reconstructing the road and increasing drainage capacity.

The project is scheduled to begin in the spring of 2018 as to not interfere with the holiday shopping season.

### Proposed Improvements

- Reconstructing approximately 700 feet of Maple Rd and 600 feet of Ash Way/ Interurban Trail using structural slabs on top of pin piles, pile caps, and grade beams
- Raising the intersection roughly five feet and a minimum of six inches above the existing 25-year flood elevation of Swamp Creek to ease flooding issues
- Increasing the drainage system's capacity to reduce upstream flooding
- Installing new fish-passable culverts on Maple Rd and Ash Way

### Timeframe and Impacts to Businesses

- In consideration of the holiday shopping season, construction is scheduled to begin in the spring of 2018 and is anticipated to last five months.
- There may be limited access to a few of the immediate surrounding businesses during construction, however the construction team will provide some way to access the businesses at all times.
- Construction work is scheduled to take place from 7 a.m. to 6 p.m., Monday through Friday.
- Detours will be created to accommodate traffic and usage of the Interurban Trail.
