When we begin discussing an Agreed Order with a Potentially Liable Person we publish a notice of in the [Site Register](#). The notice is to advise the public that discussions have commenced on the Agreed Order.

I recommend you check the *Site Register* regularly. However, I wouldn't guarantee that, in practice, this notice is published 100% of the time, so feel free to check back as well.

A draft Agreed Order must be issued for a 30-day public comment period. A great deal more public outreach is done for a public comment period for a draft Agreed Order.
