6 AUTHORIZING AN INCREASE IN CONSERVATION FUTURES TAX REVENUES
7 FOR PROPERTY TAXES COLLECTED IN 2019

9 WHEREAS, the County Council held a public hearing on November ____, 2018,
10 following public notice as required by law to consider the County's annual budget,
11 including revenue sources for calendar year 2019, pursuant to RCW 84.55.120; and
12

13 WHEREAS, the County Council, after hearing and duly considering all relevant
14 evidence and testimony presented, including evidence and testimony presented upon
15 consideration of proposed Ordinance No. 18-____, has determined that an increase in
16 conservation futures tax revenue from the previous year, in addition to the increases
17 resulting from the addition of new construction, improvements to property, newly
18 constructed wind turbine facilities, and any increase in the value of state-assessed
19 property under RCW 84.55.010, and from the refund provisions of Chapters 84.68 and
20 84.69 RCW, is necessary in order to discharge the expected expenses and obligations
21 of the County and in its best interests.

23 NOW, THEREFORE, BE IT ORDAINED, pursuant to RCW 84.55.120, that an
24 increase in property tax revenues for taxes collected in 2019, in addition to the
25 increases resulting from the addition of new construction, improvements to property,
26 newly constructed wind turbine facilities, and any increase in the value of state-
27 assessed property under RCW 84.55.010 and from the refund provisions of Chapters
28 84.68 and 84.69 RCW, is hereby authorized in the amount of \$38,652 for the 2019
29 conservation futures levy, which is a percentage increase of one (1) percent from the
30 previous year.
