- When a holiday falls on a Friday, Criminal Trial Call will be held at 1:00 and the Video Session will be held at 2:00 on the last court day of the week.
- When a holiday falls on a Tuesday, Wednesday or Thursday, the calendars for that day will be cancelled.
- Thanksgiving holiday is observed on a Thursday and Friday, so Wednesday becomes the Friday schedule.
