

North Road Update

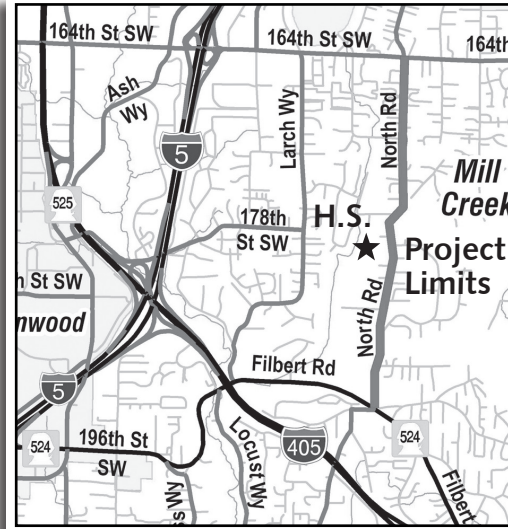

If you haven't already, you will soon see utility crews working along North Road in preparation for Snohomish County's project to add sidewalks, bike lanes and a center turn lane between 164th St SW and Filbert Road. This is a two-year project that will begin next spring and be finished in 2015. Utility poles are being moved now, and intermittent single lane road closures will be in effect along the corridor through the end of this year.

If you have plants or other landscaping items in the public right-of-way, and you wish to save them, make sure to move them this fall/winter. The right-of-way area will be cleared when the project begins in the spring. We will mail information about the schedule and traffic impacts in the spring after the construction contractor is hired, and before construction begins.
