2011 Action Plan	Due to cuts in 2011 CDBG, HOME, and ESG funds, reduced funding awards for 28 projects by a total of \$417,944. In addition, re-allocated \$167,757 in returned funds from public facility and infrastructure project cost under runs to 2011 public facility and infrastructure projects to offset the funding cuts.	11/7/11
2011 Action Plan	Due to cuts in 2011 CDBG and HOME funding: 1) reduced funding to the HomeSight <i>Puget Sound Homebuyers Assistance</i> project by \$101,991 to \$210,000 and reduced estimated households to be served from nine to six; 2) reduced funding to the Parkview Services <i>Homeownership for People with Disabilities</i> project by \$71,009 to \$167,524 and reduced estimated households to be served from seven to five ; and 3) reduced funding to the Snohomish County Human Services Department <i>Weatherization Related Minor Home Repair Program</i> by \$50,000 to \$100,000 and reduced households to be served from 90 to 50.	2/1/12
2011 Action Plan	Canceled the award of \$112,500 for the Housing Hope <i>Homeownership Assistance Fund</i> and re-allocated these funds to the Housing Hope <i>Woods Creek Village</i> rental housing project, increasing this latter award to \$532,641.	2/1/12
2007 Action Plan	Cancelled \$8,843.87 in HOME funds to the Everett Home for Good <i>Urban Gardens Broadway</i> project and re-allocated these funds to the City of Everett <i>Community Housing Improvement Program (CHIP)</i> .	2/1/12
2008 Action Plan	Cancelled \$191,156.13 in Everett HOME set-aside funds for the Home for Good <i>Urban Gardens Broadway</i> project and re-allocated these funds to the City of Everett <i>Community Housing Improvement Program (CHIP)</i> .	2/1/12
2011 Action Plan	Awarded \$418,686 in Everett HOME set-aside funds to the City of Everett <i>Community Housing Improvement Program (CHIP)</i> .	2/1/12

2008 Action Plan	Made final budget adjustment to Homeless Prevention and Rapid Re-housing (HPRP) program to fully expend the funds and close out the grant. A total of \$79,375.97 was transferred from Data Collection and Evaluation, Administration, and Rapid Re-housing Activities to Homeless Prevention Activities, as there was more need in this latter category.	3/1/12
2008 Action Plan	Cancelled remaining balance of \$107,091.58 of CDBG-R Award for the HASCO <i>Single Family Rehabilitation Loan Program Energy Conservation Improvements</i> as agency decided to discontinue the program. Re-allocated these funds as follows: 1) \$90,000 for the new Darrington <i>Emergency Generator</i> project and 2) \$17,091.58 to the existing Parkview Services <i>Parkview Homes IX</i> project to help cover cost over runs.	5/2/12
2011 Action Plan	Due to agency closure, reduced the Deaconess Children's Services <i>Teen Parent Advocacy</i> project award to \$5,448.10 and re-allocated the remaining balance of \$16,341.90 to Cocoon House to continue the project.	5/2/12
2011 Action Plan	Cancelled the 2011 CDBG award of \$352,524 for the HASCO Single Family Rehabilitation Loan Program as agency decided to discontinue the program. The funds were re-allocated to other affordable housing activities in the 2012 Action Plan.	5/9/12
2009 Action Plan	Cancelled the remaining balance of \$170,271.91 of HOME award for the HASCO Single Family Rehabilitation Loan Program as agency decided to discontinue this program. The funds were re-allocated to other affordable housing activities in the 2012 Action Plan.	5/9/12
2010 Action Plan	Changed the project scope for the Boys & Girls Club <i>Sultan Boys & Girls Club</i> project from rehabilitation of an existing club to construction of a new club as the original club buildings were destroyed by a fire. Identified new project site in Sultan.	5/9/12
2011 Action Plan	Added a spending plan to receive an additional \$76,048 in 2011 ESG funds made available to the Consortium by HUD. The additional funds will be used for rapid re-housing activities, HMIS costs, and County grant administrative costs. The amendment includes several additional items of information related to the amendment process and other grant requirements to receive these funds.	5/9/12
2010-2014 Consolidated Plan	Added new objective to continue to support the local Homeless Management Information System (HMIS) for required data collection, reporting, evaluation, or other management activities. HUD increased the HMIS requirements and this new objective will allow ESG funds to be used to help with HMIS costs.	5/9/12
