

# TNR Appendix A: Major Projects and Their Status

---

The road projects listed in Appendix A have been identified as major projects in the County's 2005-2025 Transportation Element (TE) or in a previous Transportation Needs Report (TNR). Appendix A-2 shows the current status (active or not active) of these projects and provides notes to help explain their current status. The reasons projects may no longer be active include:

- Completion of project
- Project was not included in 2005-2025 TE
- Annexations

Road improvement projects in the 2005-2025 TE were classified into one of three categories:

1. Critical Arterial System Improvement (CASI)
2. Arterial Level of Service Improvement (ALOSI)
3. Arterial System Enhancement (ASE)

The 2005-2025 TE has a detailed explanation of these categories in Chapter IV, Recommended Transportation Improvements.
