NOTICE IS HEREBY GIVEN that the Snohomish County Council has introduced proposed Ordinance No. 08-119, adopting the 2009-2010 Biennial Budget and making appropriations for the operation of county agencies and departments and capital improvements for the biennium beginning January 1, 2009 and ending December 31, 2010., the Executive's proposed 2009-2010 Biennial Budget, and will hold a PUBLIC HEARING on **Wednesday, October 1, 2008 at the hour of 11:00 a.m.** and continuing thereafter as necessary, to consider the **Proposed BIENNIAL BUDGET**. In addition, pursuant to Snohomish County Charter Section 2.70, the council, in conjunction with the County Executive, will be holding the **BIENNIAL PUBLIC FORUM** taking public testimony and comment on the operation of any county department.

The hearing will be held in the Henry M. Jackson Board Room located on the 8th Floor of the Robert J. Drewel Building, 3000 Rockefeller, Everett, Washington.

The Chair of the Council may choose to limit testimony to three minutes in the interest of accommodating all persons wishing to testify.
