ⁱ HEARINGS FOR C-304 (NOW NAMED 3A) & DEPT. 8 (NOW NAMED 3F) ARE SYNCHED TO START AT 9, 10, 11 & 3 TO FACILITATE MOVEMENT OF IN-CUSTODY DEFENDANTS. THUS, IN-CUSTODY MATTERS MAY ONLY BE SCHEDULED AT THE TOP OF AN HOUR. NO HEARINGS REQUIRING TRANSPORT OF IN-CUSTODY DEFENDANTS MAY BE SCHEDULED AFTER 3PM WITHOUT ADVANCE COURT APPROVAL. NO MORE THAN SIX (6) IN-CUSTODY DEFENDANTS SHOULD BE SCHEDULED FOR ANY TIME SLOT (E.G., THERE CAN BE 5 IN-CUSTODY DEFENDANTS IN C-304/3A & 1 IN CUSTODY DEFENDANT IN D. 8/3F FOR THE 9AM HEARING SLOT). C-201/2A WILL NO LONGER BE USED FOR CRIMINAL HEARINGS BECAUSE IT IS NEEDED FOR CRIMINAL JURY TRIALS. THIS CALENDAR HAS BEEN DEVELOPED PURSUANT TO THE COVID-19 EMERGENCY ORDERS ISSUED BY THE COURT. IT MAY BE CHANGED WITHOUT NOTICE. UPDATES WILL BE POSTED ON THE COURT'S WEBSITE UNDER CALENDARS AND SCHEDULES, CRIMINAL HEARINGS RESTART SCHEDULE.

ⁱⁱ POST-CONVICTION MOTIONS WITHOUT ORAL ARGUMENT WILL BE CALENDARED FOR TUESDAY MORNINGS AT 8:30AM.

ⁱⁱⁱ THE C-304/3A "CRIMINAL HEARINGS/PLEA & SENTENCING" SCHEDULE IDENTIFIES IT AS THE COURTROOM WHERE SHORT HEARINGS & HEARINGS WITHOUT ORAL ARGUMENT ARE HEARD (E.G., IN CUSTODY ARRAIGNMENTS, TRIAL SETTINGS, MOTIONS TO ADDRESS BAIL/RELEASE, FUGITIVE MATTERS, MOTIONS FOR CERTIFICATE OF DISCHARGE, MOTIONS FOR CERTIFICATE OF RESTORATION OF OPPORTUNITY, MOTIONS TO CONTINUE, MOTIONS TO COMPEL, MOTIONS TO QUASH, MOTION TO REINSTATE BAIL, MOTIONS TO SEAL, STAYS, MOTIONS TO VACATE CONVICTION, TAP CONTINUANCES, WAIVER OF JURY TRIAL, WEAPON SURRENDER REVIEWS, ETC.). THE JUDGE IN C-304/3A SHALL ALSO ADDRESS DEADLINE FILINGS AND ADDRESS POST-CONVICTION MOTIONS WITHOUT ORAL ARGUMENT (E.G., LFO MOTIONS, MOTIONS RELATING TO RALJ APPEALS (SUCH AS MOTIONS FOR ADDITIONAL TIME TO FILE BRIEFING, MOTION TO DISMISS RALJ APPEALS, ASSIGNING OUT RALJ APPEALS, ETC.). THE C-304/3A JUDGE MAY ASSIGN MATTERS TO THE OTHER CRIMINAL HEARINGS JUDGE IF THE JUDGE NEEDS ASSISTANCE. NON-SPECIAL SET SENTENCINGS ARE AT 3PM. 1 CALENDAR SPACE = A CASE WITH UP TO THREE CHARGES FOR EITHER PLEA OR SENTENCING.

^{iv} THE FRIDAY 9:30AM TRIAL CALL SHALL BE LIMITED TO TRIAL ASSIGNMENTS. NO CONTESTED CONTINUANCE MOTIONS SHALL BE HEARD AT TRIAL CALL.

^v THE FRIDAY 3PM "CRIMINAL MOTIONS CALL" CALENDAR SHALL BE FOR THE PURPOSE OF CONFIRMING THE SPECIFIC DATE & TIME THAT AN EXTENDED CRIMINAL MOTION WILL BE HEARD THE FOLLOWING WEEK. **CASES MAY ONLY BE PLACED ON THE CRIMINAL MOTIONS CALL CALENDAR BY FILING A CRIMINAL CALENDAR NOTE AND FOLLOWING THE INSTRUCTIONS ON THAT DOCUMENT.** THE CRIMINAL CALENDAR NOTE IS LOCATED ON THE COURT'S WEBSITE UNDER "EMERGENCY CALENDAR NOTES." MOTIONS WILL NOT BE CONFIRMED IF THE ATTORNEYS DO NOT AFFIRMATIVELY STATE THAT ALL PARTIES AND ALL WITNESSES ARE AVAILABLE FOR THE ASSIGNED HEARING DATE AND TIME. WORKING COPIES MUST BE PROVIDED AT THE MOTIONS CALL CALENDAR.

3.5 HEARINGS IN BENCH TRIAL CASES SHALL BE HEARD AT THE TIME OF TRIAL, ALL OTHERS SHALL BE SET TO AN EXTENDED CRIMINAL MOTION CALENDAR.

^{vi} THE D. 8/3F "EXTENDED CRIMINAL MOTIONS/OUT OF CUSTODY ARRAIGNMENTS" SCHEDULE IDENTIFIES THE LOCATION WHERE MOST EXTENDED CRIMINAL MOTIONS WILL OCCUR (E.G, 3.5, 3.6 HEARINGS, & SELL HEARINGS), AND OUT OF CUSTODY ARRAIGNMENTS. THERE WILL BE ONE (1) EXTENDED CRIMINAL MOTION SCHEDULED EACH HOUR, M-F, 9:00AM - NOON. IF MATTERS ARE APPRECIABLY SHORTER THAN AN HOUR, MORE THAN ONE MAY BE SET PER HOUR (BUT NO MORE THAN THREE 15 MINUTE MATTERS, OR TWO 20 MINUTE MATTERS MAY BE SET PER HOUR). UP TO TWO SPECIAL SET SENTENCINGS MAY BE SCHEDULED AT 1PM, MONDAY - FRIDAY. OUT OF CUSTODY ARRAIGNMENTS BEGIN AT 3PM.

Summary of Changes to Criminal "Restart" Calendar
