4. I have a right to be present at all court proceedings involving my case.
5. I do hereby waive my right to be present at my trial confirmation hearing. However, I also understand that my presence will be required for trial, sentencing or other hearings on various motions which may be brought before the court. 6. I have the right to a speedy trial. I am making a knowing, intelligent and voluntary waiver of my right to a speedy trial and have no objection to the court continuing my trial date. I agree that the time between my current trial date and the new trial date will be excluded under CrRLJ 3.3.
7. I do not intend to confirm my case for trial as currently scheduled. However, the court may deny a motion to continue and confirm the case for trial in which case I must appear ready for trial on the date indicated above.
8. If my motion to continue is granted, the Court will issue new court dates in the presence of my attorney. It is my responsibility to obtain those new dates and attend as required. A warrant for my arrest may issue if I fail to attend.
9. I have a continuing obligation to comply with all pretrial release conditions.
