1. Petitioner(s), proposed guardian(s) and legal parents or guardians (hereafter "parties") shall obtain the Guardian ad Litem (GAL) Personal Information Form from the Forms Repository in the Commissioner Hallway or from <https://snohomishcountywa.gov/5523/Snohomish-County-Superior-Court-Forms>, complete the form, and **return to the GAL** within 48 hours after entry of this order (or no later than **4 PM on** _____).
2. All parties shall obtain any other supplemental materials, including additional questionnaire and release forms, from the GAL and return to the GAL at the deadline determined by the GAL.
3. The GAL report shall be provided to the Court and the parties seven (7) court days prior to the review hearing set below.
4. Responses to the GAL report shall be provided to the GAL and the Court two (2) court days prior to the review hearing set below.
5. The GAL shall inform the court of any failure to comply with any of the above requirements, and request a continuance if lack of compliance has made completion of a timely report impossible.
