ESTIMATED ADVANCE FEES ARE REQUIRED PRIOR TO SERVICE ATTEMPT. IF THE FEES ARE LESS, A REFUND CHECK WILL BE ISSUED. IF THE FEES ARE MORE, A BILL WILL BE SENT FOR ADDITIONAL FEES.

**MILEAGE:**

CURRENT PUBLISHED MILEAGE RATE FOR BUSINESS TRAVEL DEDUCTIONS IS SET BY THE IRS. CURRENT PUBLISHED MILEAGE RATE SET BY IRS CAN BE FOUND ON THEIR WEB PAGE. MILEAGE IS PER MILE ROUND TRIP FROM THE COURTHOUSE, WITH A \$10.00 MINIMUM CHARGE (PER RCW 36.18). WHEN SERVING MORE THAN ONE PROCESS FOR THE SAME CAUSE OR ON THE SAME PERSON NOT REQUIRING MORE THAN ONE JOURNEY FROM THE COURTHOUSE, MILEAGE WILL BE CHARGED ONLY FOR THE MOST DISTANT SERVICE. ADVANCE FEES SHALL BE DOUBLED FOR ROUND TRIP MILEAGE MORE THAN 75 MILES.
